Welcome to 2023! As a medical aid fund that is dedicated to continually finding more ways to improve your holistic health, we are excited to announce that we continue to reinvent ourselves so that you can be the best possible you.

As the saying goes, "new year, new you," and to kick things off we are excited to introduce the Four (4) new health plans which are as follows: **Access, Comprehensive, Executive and Prestige**. All our existing clients will be moved to new benefits options. Further communication about these exciting developments will be shared in the first quarter of the year. These new options offer the flexibility to choose and/or design your benefit plan with up to 16 different package options on both in-patient and out-patient care. This added flexibility is the first of its kind in Botswana, and places you at the heart of your health and wellness by giving you the option to select a health plan that suits your specific needs. We cannot wait for you to explore these options and make your health plan selection truly your own.

With the introduction of these four new health plans, we will be discontinuing the A-Standard health plan (AS) for new clients. Clients currently under this option will be allowed to continue with it, however, we will no longer be onboarding any new members on to the plan, effective 1st January 2023.

The scheme will also introduce the use of the principal-Adult-Child (PAC) pricing structure which is simple, accurate and differentiates pricing for child and adult dependents. This pricing structure will, for 2023, only be applied to new individual clients and companies joining the fund. Existing Bomaid clients will enjoy this pricing benefit from 2024.

The following new and enhanced benefits have been embedded in the new health plans :

New Benefits

- Introduction of a virtual consultations benefit for all health plans.
- Wellness rewards benefits to incentivize participation in wellness initiatives.
- Introduction of enhanced child immunization benefits.
- Introduction of a Connected Service Provider network for value-based care and to minimize the out-of-pocket component of our members.
- Food handlers benefit.

Benefit Enhancements

- The full suite of preventative benefits on all options.
- Removal of age limits on blood glucose and cholesterol tests.
- Data collection and follow up on self-screening platforms.
- Enhanced maternity benefits to include cover for maternity for dependents.
- Contraceptives including oral contraception, patch, injection, and intrauterine devices (IUD) including dependents.
- Unlimited telephonic consultation services for mental health.
- Unlimited Hospitalization on Prestige Max.
